RETURNING ANNUAL INVESTMENT PLAN FOR CY 2018 OF BARANGAY NEW CASAY, BRAULIO E. DUJALI, DAVAO DEL NORTE BACK TO ITS BARANGAY OF ORIGIN FOR MODIFICATION.

WHEREAS, the Annual Investment Plan for Calendar Year 2018 of Barangay New Casay, this municipality was forwarded to this level and later was referred to the Committee on Ways and Means for review and approval;

WHEREAS, during the committee hearing conducted for the said purpose, the following findings were noted:

1. The total amount of Summary of Projected Income and Expenditures does not correspond to the amount of Programs/Projects/Activities (PPAs), particularly the
  - 5% Calamity Fund under the 30% Response and Rehabilitation
  - 10% Sangguniang Kabataan (SK) Fund;
2. Program/Project/Activity and funds for the honorarium of Barangay Agricultural Extension Worker (BAEW) in pursuance to Municipal Ordinance No. 2017-202 in the Annual Investment Plan of the said Barangay, were not included.

WHEREAS, this honorable body moved to return the Annual Investment Plan for Calendar Year 2018 of Barangay New Casay back to the Barangay of origin for modification, citing the above mentioned findings;


WHEREFORE, on motion of Hon. Yasmin V. Campion, and duly seconded by majority of the members present, it is hereby

RESOLVED TO RETURN AS THIS BODY HEREBY RETURNS ANNUAL INVESTMENT PLAN FOR CY 2018 OF BARANGAY NEW CASAY, BRAULIO E. DUJALI, DAVAO DEL NORTE FOR MODIFICATION.


