AMENDING RESOLUTION NO. 2016-74 OTHERWISE KNOWN AS "RESOLUTION ADOPTING THE INTERNAL RULES OF PROCEDURE OF THE EIGHTH (8TH) SANGGUNIANG BAYAN OF BRAULIO E. DUJALI, DAVAO DEL NORTE" PARTICULARLY SECTION 20 AND SECTION 34 THEREOF.

WHEREAS, Section 20 of Resolution No. 2016-74, provides that, "If a schedule of a regular session falls on holiday, training and seminars or any official activity that necessitates attendance of the members, the Sangguniang Bayan shall conduct said session a day before or any day as agreed upon by the majority";

WHEREAS, there are instances already that a holiday falls on Monday which is the schedule of this council's regular session, thus Section 20 of Resolution No. 2016-74 cannot be applied considering that the day before Monday is Sunday and is a non-working day for all government institutions, including LGUs;

WHEREAS, Section 34, particularly numbers 2, 3, 7, 8, 9, 13, 14 and 15 thereof shall likewise be amended as a result of the untimely demise of the late Hon. Gerald J. Abiera and the subsequent appointment as member of the Sangguniang Bayan of Hon. Eduardo M. Zapata and consequently replacing the latter in the following Committees of which he formerly chaired or was a member as shown below:

- 1) Vice Chairman-Committee on Agrarian Reform, Agriculture and Cooperative

- 2) Chairman-Committee on Education and Culture, Information, Science and Technology
- 3) Member-Committee on Public Works, Facilities and Utilities and Transportation and Communication
- 4) Chairman-Committee on Youth and Sports Development
- 5) Member-Committee on Barangay Affairs/Civil Society Organization
- 6) Member-Committee on Legal Matters, Fact Finding, Justice, Laws, Ordinances and Resolutions
- 7) Member-Committee on Social Services, Women, Children and Family Relations
- 8) Member-Committee on Cultural Communities

WHEREFORE, on motion of Hon. Gregorio S. Facula and duly seconded all members present, it is hereby

RESOLVED TO AMEND AS THIS BODY HEREBY AMENDS RESOLUTION NO. 2016-74 OTHERWISE KNOWN AS "RESOLUTION ADOPTING THE INTERNAL RULES OF PROCEDURE OF THE EIGHTH (8TH) SANGGUNIANG BAYAN OF BRAULIO E. DUJALI, DAVAO DEL NORTE" PARTICULARLY SECTION 20 AND SECTION 34 THEREOF.


