WHEREAS, the roads' sad state is aggravated by the onset of rainy seasons thereby making one's travel to and from this municipality very uncomfortable and too risky;

WHEREAS, this body believes that repair and maintenance of roads affected by the implementation of projects is integrated in the Program of Works and is given substantial allocation as well, by the concerned contractor;

WHEREAS, this body likewise believes that aside from being mandated by law that repair and maintenance shall also be assisted by contractors whose equipment had caused the damage, a

commitment for such repair and maintenance had been expressed during the projects' pre-implementation conference;


WHEREFORE, on motion of Hon. Gregorio S. Facula duly seconded by all Sangguniang Bayan members, it is hereby


