GRANTING AUTHORITY TO THE LOCAL CHIEF EXECUTIVE, MUNICIPAL ACCOUNTANT AND THE MUNICIPAL TREASURER TO OPEN A BANK ACCOUNT AT THE LAND BANK OF THE PHILIPPINES, PANABO CITY BRANCH FOR GENERAL FUND-20% DEVELOPMENT FUND PURPOSELY TO EASILY DETERMINE THE ACCOUNTING, UTILIZATION AND STATUS OF IMPLEMENTATION OF THE PROGRAMS/PROJECTS/ACTIVITIES OF THIS MUNICIPALITY.

WHEREAS, this body received a letter from Mayor Leah Marie Moral-Romano requesting this body to grant authority to the Local Chief Executive, Municipal Accountant and the Municipal Treasurer to open a Bank Account at the Land Bank of the Philippines, Panabo City Branch for General Fund-20% Development Fund purposely to easily determine the accounting, utilization and status of implementation of the programs/projects/activities charged against the said fund;

WHEREAS, this resolution is in pursuance to Section 313 (c) of RA No. 7160 otherwise known as, "An act providing for a Local Government Code of 1991, which states that:

"Development projects funded from the share of the local government unit concerned in the internal revenue allotment and such other special accounts which may be created by law or ordinance.

Receipts, transfers, and expenditures involving the foregoing special accounts shall be properly taken up thereunder.

Profits or income derived from the operation of public utilities and other enterprises, after deduction for the cost of improvement, repair and other related expenses of the public utility or economic enterprise concerned, shall first be applied for the return of the advances or loans made therefor. Any excess shall form part of the general fund of the local government unit concerned”;

WHEREAS, finding that the intention to open a bank account for the afore cited purpose is meritorious, hence it is just proper and fitting that the said request be approved;

WHEREFORE, on motion of Hon. Yasmin V. Campion and duly seconded by all SB members it is hereby,


