FOREWORDS

The Local Government Unit of Braulio E. Dujali in its vision to become an agro-industrialized municipality strengthens its partnership with the Department of Agriculture and its attached agencies on Rice Mechanization Program under which it availed through counter parting scheme the following equipment, to wit; Combined Rice Harvester, Rice Reaper and Mechanized Rice Transplanter in order to increase productivity of farmers.

In order to sustain the Rice Mechanization Program, there is a need to maintain the operation of these three (3) farm implements for the farmer-clients. Therefore, it is just right and proper to formulate and adopt policies and guidelines in its utilization, hence;

PRESCRIBING POLICIES AND GUIDELINES ON THE UTILIZATION OF COMBINED RICE HARVESTER, RICE REAPER AND MECHANIZED RICE TRANSPLANTER OWNED AND OPERATED BY THE MUNICIPALITY OF BRAULIO E. DUJALI, DAVAO DEL NORTE

BE IT ENACTED, by the Sangguniang Bayan that:

SECTION 1. Title of the Ordinance. This ordinance shall be known as the Combined Rice Harvester, Rice Reaper and Mechanized Rice Transplanter Operation Ordinance of the Municipality of Braulio E. Dujali, Davao del Norte.

SECTION 2. Declaration of Policy. The Municipality of Braulio E. Dujali and the Department of Agriculture Regional Field Unit XI through the Rice Program envision of alleviating poverty and provide food security to the populace. Through this program the department provides Combined Rice Harvester, Rice Reaper and Mechanized Rice Transplanter to this municipality.

SECTION 3. Definition of Terms.

1. **Combined Rice Harvester** - is a machine used to cut and thresh palay in the field.
2. **Rice Reaper** - a machine used to harvest matured Palay by cutting the stems only.
3. **Mechanized Rice Transplanter** - a machine used to transplant rice seedlings onto paddy field.
4. **Rice** - a starchy grain used as a staple food throughout the world for its edible grain.
5. **Agricultural Land** - the land base upon which agriculture is practiced or land that is suited for farming.
6. **Area** - the extent or measurement of a surface or piece of land.
7. **Farmer** - a person who raises animals and plants for food or a person who owns or manages a farm.
8. **Fuel** - any material that is burned or altered in order to obtain energy and heat or to move an object.
9. **Hectare** - a unit of area equal to 10,000 square meters.
10. **General Fund** - funds are of universal uses.
11. **Trust Fund** - funds are of limited uses (for maintenance and repair of farm equipment and wages) the LGU will maintain record of receipts on its utilization.
12. **MAGRO Staff** - personnel of Municipal Agriculture Office engaged in the delivery of extension services.
13. **Farmer-Client** - person who is entitled to avail the utilization of farm equipment.

SECTION 4. Scope. The operation of the Combined Rice Harvester, Rice Reaper and Mechanized Rice Transplanter shall serve the Municipality of Braulio E. Dujali farmer-clients only.

Farmer-client residing in Braulio E. Dujali who have rice farm areas outside the boundaries of municipality shall be accommodated if the machine is available.

SECTION 5. Management. The Municipal Agriculture Office shall be the direct responsible for the management of the Combined Rice Harvester, Rice Reaper and Mechanized Rice Transplanter.

SECTION 6. Service Charge. The following charges are set for the use of the following equipment:

6. a Rice Combined Harvester

A. Sharing Scheme (in sack/cavan):

I. Farmer

-

91% of the gross harvested of threshed palay

- II. Combined Rice Harvester - 09% of the gross harvested of threshed palay
- B. Ratoon Sharing Scheme:
 - Above 25 sacks harvested/ha. - 20% of the gross harvested palay
 - Above 15 sacks harvested/ha. - 30% of the gross harvested palay
 - 14 sacks & below harvested/ha.- 40% of the gross harvested palay
- 6. b Mechanized Rice Transplanter
 - A. Mode of Payment
 - Php2,500.00/hectare - with operator and assistance of MAGRO Staff during seed bed preparation and seed bed tray is provided
 - Php1,300.00/hectare - with operator but without assistance of MAGRO Staff during seed bed preparation yet seed bed tray is provided.
- 6. c Rice Reaper
 - Php2,500.00/hectare - operator provided by the LGU

SECTION 7. Operation Guidelines.

7.a For Combined Rice Harvester

The MAGRO Staff shall conduct first a survey if the farm is feasible for operation of such equipment after the Farmer-client filled up the form as provided in Section 8.

The unit must be operated by one (1) competent driver, one (1) helper and seasonal laborers for hauling of palay sack to assemble point within the farm.

80% of receipts from combined rice harvester services shall be treated to the trust fund and shall be utilized for the up keep and maintenance of the combined rice harvester as well as other services and the 20% will be treated to the general funds.

The Local Government Unit of Braulio E. Dujali shall pay for the wages of the operator and helper of the combined rice harvester.

The LGU shall shoulder the fuel of the machine and the wages of the laborer to be taken from its share.

7.b Rice Reaper

Payment received from rental of the rice reaper shall be treated 60% Trust Fund and 40% General Fund.

The Farmer-client shall fill-up forms provided in Section 8 and shall pay the amount due to the Municipal Treasurer's Office and present such receipt to the MAGRO Staff for scheduling.

The farmer shall shoulder the fuel of the rice reaper.

7.c For Mechanized Rice Transplanter

The Farmer-client shall fill-up forms provided in Section 8 and shall pay the amount due to the Municipal Treasurer's Office and present such receipt to the MAGRO Staff for scheduling.

The farmer shall shoulder the fuel of the transplanter and the meals and snacks of the operator and the laborer.

Payment received by the Municipal Treasurer's Office shall be treated 60% Trust Fund for the maintenance and the remaining 40% to the General Fund.

SECTION 8. Application Form. The farmer-client shall fill-up this form for operation scheduling.
