CREATING BARANGAY AGRICULTURAL EXTENSION WORKER AS PART OF THE REGULAR FUNCTIONARIES OF THE BARANGAY IN THE MUNICIPALITY OF BRAULIO E. DUJALI, DAVAO DEL NORTE AND APPROPRIATING FUNDS FOR THE IMPLEMENTATION THEREOF

FOREWORDS

Food Security is everybody's primary concern. With the exponential population growth, the government is hard pressed to meet the food requirement of the nation. The arable and productive lands are shrinking due to high demand of residential, commercial and industrial areas.

Braulio E. Dujali is basically an agricultural town. Its socio-economic development is highly dependent on agriculture sector. The Municipal Agriculture Office (MAGRO) is the frontline Local Government Agency responsible for the delivery of extension and basic agricultural services to the farmers. Looking at the office's present set up, there are four (4) permanent AEWs reinforced by another four (4) Contract of Service Workers who are doing frontline works on the field. These AEWs are catering the needs of around 10,000 people engaged into livestock raising, fisheries and farming of high

value crops, vegetables and rice. By ration, there are about 1:2,500 (1 AEW: 2,500 farmers) since Contract of Service Workers have limited functions.

There is a need to provide the farmers with access to information and services to increase their production and income. Farmers' empowerment through enhancement of their capability could lead to sustainability and development and this can be done by intensifying the techno-transfer mechanism and support services of MAGRO. Given the financial constraints, there is a need to pull resources with other stakeholders especially the barangays.

SECTION I. This ordinance shall be known as ***“Barangay Agricultural Extension Worker (BAEW) Creation Ordinance of the Municipality of Braulio E. Dujali, Davao del Norte”***

SECTION II. Acronyms and terms that can be found in this ordinance shall be defined as follows:

1. **BAEW**- Barangay Agricultural Extension Worker
2. **AEW** - Agricultural Extension Worker
3. **IPM-FFS** – Integrated Pest Management-Farmers Field School
4. **DIFS** – Diversified and Integrated Farming System
5. **LGU**- Local Government Unit
6. **DA**- Department of Agriculture
7. **Farm plan**- budget & activities for the entire farming season
8. **Arable**- capable of producing crops; suitable for farming
9. **Vaccination**- administration of vaccines to stimulate the hosts' immune response. This includes any preparation intended for active immunological prophylaxis
10. **Treatment**- the act or manner or an instance of treating someone or something
11. **Para-Technician**- conducts experiment, collects and analyzes data and prepares report based on findings

SECTION III. The purpose of this ordinance is to recognize the efforts of the BAEW who shall be serving as Para-Technician in her/his Barangay.

SECTION IV. The functions of the BAEW shall be as follows:

1. A) Serves as a model farmer in their respective barangay;
B) Assists the Municipal Agriculture's Office (MAGRO) personnel to effectively implement programs/projects relative to food security of the barangay and the Municipality as a whole.
2. A) Does inventory of animal population and area planted per commodity survey to maintain updated yearly commodity profiling;
B) Prepares farm plan of Diversified Integrated Farming System (DIFS) of at least ½ ha. that will serve as their actual laboratory for farmers' trainings;
C) Implements/establishes DIFS demo farm, if ever the selected BAEW does not have an existing DIFS yet;
D) Assists the farmers in their PCIC application/processing;

E) Does pest and disease surveillance for both crops and livestock and immediately reports to agency concern for possible and appropriate action;

F) Maintains close coordination and linkages with line agencies and NGOs;

G) Submits monthly/quarterly accomplishment report to the Municipal Agriculture's Office, copy of the same report shall also be furnished to their respective Barangay Government;

H) Facilitates collection of soil sample for analysis;

I) Does other work or function as may be required.

SECTION V. There shall be assigned BAEW in the following barangays, to wit:

SECTION VI. Requirements.

1. Qualifications of BAEW:

- a. Shall be a bona fide resident of the barangay she/he will be serving;
- b. Shall be at least a high school graduate;
- c. A graduate of IPM-FFS program/s of the LGU or DA-Regional Field Office XI;

2. Funds for this purpose:

- a. Shall be taken from the Annual General Fund of the Municipal Government and Annual General Fund of the Barangay Government for honoraria, travel and meals expenses:

3. Appointment:

- a. Shall be appointed by the Municipal Mayor upon recommendation of the Barangay Captain, her/his term of office shall be coterminous with that of the appointing authority;
- b. The appointment shall be terminated upon the evaluation and recommendation of the Municipal Agriculturist with the coordination of the Barangay Captain if found not performing satisfactorily of her/his duties.


SECTION VII. This Ordinance shall take effect upon approval.




