WHEREAS, this body recently received a Certification from the Management of TADECO, Inc. stating among others that the said area as additional school site of Purok 3A at Barangay


Tanglaw is free from any encumbrances, thus authority to the Local Chief Executive to purchase is necessary to be granted;

WHEREFORE, on motion of Hon. Yasmin V. Campion, duly seconded by all members, it is hereby;


