PROVIDING FINANCIAL INCENTIVES TO ATHLETES/PLAYERS OF THE MUNICIPALITY OF BRAULIO E. DUJALI, DAVAO DEL NORTE WHO WILL WIN IN THE DAVRAA AND PALARONG PAMBANSA AND APPROPRIATING FUNDS THEREFOR

EXPLANATORY NOTE

The Municipality of Braulio E. Dujali promotes excellence in sports by looking after the welfare of its student athletes who are qualified to compete in the Davao Region Athletics Association (DAVRAA) and Palarong Pambansa by providing financial incentives. This initiative is a sign of this LGUs' grateful appreciation of their time, effort, talent and hardships in training and motivates them as well in order to become DAVRAA and Palarong Pambansa ~~Players~~ and winners.

Be it Ordained by the Sangguniang Bayan of Municipality of Braulio E. Dujali that:

SECTION I. TITLE. This Ordinance shall be known as "AN ORDINANCE PROVIDING FINANCIAL INCENTIVES TO ATHLETES/PLAYERS OF THE MUNICIPALITY OF BRAULIO E. DUJALI, DAVAO DEL NORTE"

SECTION II. DEFINITION OF TERMS. As used in this Ordinance, the following terms shall mean:

- a. Athlete/Player – a student who plays in the DAVRAA meet and Palarong Pambansa Competition.
- b. Bona fide student – students of the school within the Municipality of Braulio E. Dujali.
- c. Winner –a student who wins in the DAVRAA and Palarong Pambansa Competition

SECTION III. COVERAGE. This Ordinance shall apply to all bona fide students of the Municipality of Braulio E. Dujali and are likewise winners of games in the DAVRAA meet and Palarong Pambansa competitions, respectively.

SECTION IV. REQUIREMENTS. The coaches/trainers shall submit the certified list of winners of different kind of games to the Office of the Municipal Mayor or to her/his authorized representative for their information and corresponding preparation of necessary papers for the disbursement of incentives.

SECTION V. AMOUNT OF INCENTIVES. The athlete/player/winner, upon verification, shall receive incentives based on the following category:



SECTION VI. FUND SOURCE. Funds for this purpose shall be taken from the General Fund and Special Education Fund of the Local Government Unit of Braulio E. Dujali.




