WHEREAS, a letter dated February 13, 2017 of Atty. Leah Marie Moral-Romano, Municipal Mayor was addressed to the Sangguniang Bayan through Hon. Donna Mae B. Bernadas, Ed.D, Municipal Vice Mayor for the adoption of a resolution granting omnibus authority to the Local Chief Executive to enter into Memorandum of Agreements/undertakings; sign in contracts or any instruments relating to receipt of donations, grants, programs and projects with funding that will come from the congressional office, provincial and national government agencies and non-government organizations;

WHEREAS, this honorable body carefully deliberated on the matter and on unanimous accord moved to confirm the said request, for reasons that they are convinced of the necessity of such authority in order that programs and projects beneficial to majority of the populace can immediately be implemented and it likewise gives the Local Chief Executive a free hand and need not seek prior


authority from the Sangguniang Bayan every time she has to source out more funds and assistance from government and non-government agencies and organizations;
