WHEREAS, the Annual Budget for Calendar Year 2017 of Barangay Dujali, Cabayangan was submitted to this Honorable Council, for scrutiny and review;

WHEREAS, during the committee hearing conducted for the said purpose, the following findings were noted:

- 1. The Annual Budget of Barangay Cabayangan for CY 2017 was submitted for review of this honorable body beyond the required period;
- 2. The amount for Leave Benefits, Cash Gifts, Mid-Year Bonus and Year End Bonus of Personnel or Official as to its program/project/activity and MFO was not specified in the AIP of Barangay Cabayangan;

WHEREAS, based on the above mentioned findings, the following are hereby recommended, to wit:

- 1. Submission of Barangay Annual Budget for review shall strictly adhere to Section 333 of RA 7160, otherwise known as Local Government Code 1991.
- 2. Appropriation for Personnel Services that were not included in the AIP of Barangay Cabayangan shall be reverted to unappropriated balance.
