**RESOLUTION NO. 2017-57**

**RETURNING BARANGAY ORDINANCE NOS. 6 AND 7 ALL SERIES OF 2016 OF BARANGAY DUJALI, BRAULIO E. DUJALI TO ITS BARANGAY OF ORIGIN FOR MODIFICATION**

WHEREAS, this august body was in receipt of a letter dated March 14, 2017 of Ms. Ethma B. Bayog, Barangay Secretary of Barangay Dujali, endorsing Barangay Ordinance Nos. 6 series of 2016 known as "An Ordinance adopting the official seal of the Barangay Dujali, Braulio E. Dujali, Davao del Norte and for other purposes" and Barangay Ordinance No. 7 series of 2016 known as, "An Ordinance giving service award to all elected Barangay Officials of Barangay Dujali, Braulio E. Dujali, Davao del Norte who had served for three (3) consecutive terms" for review and appropriate action;

WHEREAS, this matter was then forwarded to the Committee on Ordinances and Resolutions and on April 19, 2017 convened to thoroughly discussed the merits of said Barangay Ordinances and thereafter recommended to return the same to its barangay of origin for modification based on the following findings:

Municipal Ordinance No. 6 Series of 2016

1. In section 3 line no. 2, the phrase **at the next page** should be removed.
2. Page 2 no. 2 letter a, instead of **water buffalo (Carabao)** it shall be **Carabao** only since water buffalo does not originate in Barangay Dujali and it is not purposely used for farming.
  - a. Page 2 no. 4, instead of the word **council** it should be specified as **barangay council**.
3. Observe proper paging of the document. (i.e. page 1 of 22 pages). ↗

4. Footer of the document/ordinance conveying the title of the ordinance shall be placed in the upper left corner of the succeeding pages of said document.
5. Page 3, recapitulation, all phrases "**our barangay**" shall be replaced with **Barangay Dujali**.

Municipal Ordinance No. 7 Series of 2016


1. In section 2, the phrase **Ex-Officio Members** shall be defined appropriately.
2. In section 4, reconsider the allocation of amount of the ring. As such, observance to Republic Act 6713, as amended, known as Code of Conduct and Ethical Standards for Public Officials and Employees shall be noted.
3. In section 5, fund for the purpose shall be incorporated in the barangay budget of Dujali.

WHEREFORE, on motion of Hon. Yasmin V. Campion duly seconded by all members present, it is hereby


