2. Actual payments for Leave Credits of Barangay Officials shall strictly conform to the provisions of CSC and DBM Joint Circular No. 1, s. 2004.


NOW THEREFORE, on motion of Hon. Yasmin V. Campion and duly seconded by all members present, it is hereby resolved to


