WHEREAS, this honorable body was in receipt of an affidavit of Ms. Anisa M. Rama, of legal age, married and a resident of Magupising, Braulio E. Dujali, Davao del Norte;

WHEREAS, in her affidavit, Ms. Rama enumerated the alleged abuses committed against her person, by Mr. Dave D. Rama, a duly elected Kagawad of said barangay;

WHEREAS, the Sangguniang Bayan, immediately convened for meeting purposely to determine its jurisdiction over the complaint and to find out whether or not the same bears the form and substance and consequently it turned out that it cannot act momentarily on the said affidavit, unless the Complainant will submit to this honorable body a verified complaint in pursuance to Section 61 of the Local Government Code of 1991 and Section 10 of Municipal Ordinance No. 70 series of 2003 of the Sangguniang Bayan of Braulio E. Dujali.

WHEREAS, due the above stated reasons, Ms Rama is hereby advised to take note and comply the following:


- 1.) Shall come up with a verified complaint, stating therein appropriate charges she will file against the respondent.
- 2.) The said verified complaint shall be sufficient in form as per Section 61 of RA 7160 otherwise known as the "Local Government Code of 1991"


