A RESOLUTION RECOMMENDING TO ATTY. LEAH MARIE A. MORAL-ROMANO, MUNICIPAL MAYOR, FOR THE ISSUANCE OF COCKFIGHTING PERMIT TO BARANGAY CABAYANGAN, BRAULIO E. DUJALI, DAVAO DEL NORTE IN CONNECTION WITH THE CELEBRATION OF PATRONAL FIESTA OF SAN ISIDRO LABRADOR.

WHEREAS, resolution no. 08 series of 2017 of Barangay Cabayangan, this municipality was brought to the attention of this august body for appropriate action;

WHEREAS, the said resolution states among others, their request to Hon. Leah Marie Moral-Romano, Municipal Mayor through the Sangguniang Bayan Members to issue Mayor's Permit for the conduct of cockfighting to be held on May 12, 13 and 15, 2017 in connection with the celebration of patronal fiesta of said Barangay, this municipality;

WHEREAS, Sections 21 and 26 of Municipal Ordinance No. 03 s. 98, otherwise known as the Municipal Cockfighting Code of 1998 of the Municipality of Braulio E. Dujali, as amended by Municipal Ordinance No. 86 s-04, provides, that;

"...Upon the option of the Barangay Officials through Barangay Resolution, barangay may operate cockfighting in their respective jurisdiction only during barangay fiestas and sitio fiestas, provided that only three (3) days are allowed. Hence, the barangay shall have to identify in their resolution during or before the celebration.

Section 2.6 of Municipal Ordinance No. 86 s-04"...In this case Barangay Resolution to this effect shall be submitted for consideration and approval before the Sangguniang Bayan...

WHEREAS, finding the said resolution to have met the application requirements, it is just proper that said request be approved and to recommend to the municipal mayor for the issuance of cockfighting permit, on the dates stated in the foregoing;




