INFORMING THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES-ENVIRONMENTAL MANAGEMENT BUREAU-REGION XI (DENR-EMB XI) THAT THE LOCAL GOVERNMENT OF BRAULIO E. DUJALI SINCE ITS CREATION IN 1998 HAS NOT ESTABLISHED DUMPING SITE AND FIND IT UNNECESSARY TO SUBMIT A SAFE CLOSURE AND REHABILITATION PLAN (SCRP).

WHEREAS, letter dated April 4, 2017 of Atty. Leah Marie Moral-Romano, Municipal Mayor addressed to the Honorable Members of the Sanggunian Bayan of Braulio E. Dujali through Hon. Donna Mae B. Bernadas, Ed.D, Municipal Vice Mayor in connection with the requirement for this local government unit to submit its Safe Closure and Rehabilitation Plan (SCRP) to the Department of Environment and Natural Resources-Environmental Management Bureau-Region XI (DENR-EMB XI);

WHEREAS, this local government unit wishes to inform the said agency that it cannot submit the required plan inasmuch as since its creation in 1998, has not established dumping site because this small town has a minimal and manageable waste generation and kept in a safe area, however as this municipality progresses, waste generation gradually increases thus it has considered constructing a bigger building for residual containment while waiting for the common SLF to be established by the provincial government;


WHEREAS, one of the required documents for the establishment of residual containment building is the submission of the SCR of which going over to its template, the data needed are not applicable in this town, wherefore submission of said plan is not possible;
