CREATING THE TECHNICAL WORKING GROUP TO CONDUCT STUDY ON THE PROPOSED MODIFICATION OF MUNICIPAL ORDINANCE NO. 2016-191 OTHERWISE KNOWN AS, "AN ORDINANCE CREATING CERTAIN POSITIONS IN THE PLANTILLA OF PERSONNEL UNDER THE DIFFERENT OFFICES OF THE LOCAL GOVERNMENT UNIT OF BRAULIO E. DUJALI, DAVAO DEL NORTE AND APPROPRIATING FUNDS THEREOF".

WHEREAS, on its 13<sup>th</sup> regular session held on April 7, 2016, this honorable body passed and adopted Municipal Ordinance No. 2016-191, creating various permanent positions in the different offices of the Local Government Unit of Braulio E. Dujali, Davao del Norte;

WHEREAS, it was later submitted for confirmation to the Sangguniang Panlalawigan, however, the same was returned for modification on the basis that it failed to conform with some specific standards set by the Civil Service Commission (CSC) and latest issuances of the Department of Budget and Management (DBM);

WHEREAS, the Sangguniang Panlalawigan, also made a manifestation that the LGU is likely to exceed on the allowable PS Limitation should the said ordinance is confirmed. The Sangguniang Panlalawigan instead recommended lowering the number of positions to be created, thus the need to form a group of individuals from this Local Government Unit who shall take charge in making a study on this and give its final recommendation to this honorable chamber;


NOW THEREFORE, on motion of Hon. Ricky T. Delco and duly seconded by all members present, it is hereby;


