EXPRESSING SUPPORT TO TAGUM AGRICULTURE DEVELOPMENT CORPORATION (TADECO) FOR ITS EFFORT NOT ONLY IN HELPING THE REHABILITATION OF INMATES OF DAVAO PENAL COLONY (DAPECOL) AND GIVING EMPLOYMENT TO THOUSANDS OF INDIVIDUALS BUT ALSO IN ITS LAUDABLE CONTRIBUTION TO THE DEVELOPMENT OF THE MUNICIPALITY OF BRAULIO E. DUJALI, AS WELL.

WHEREAS, Braulio E. Dujali is a fourth (4th) class municipality and gets a larger portion of its revenues from real property and business taxes and regulatory fees. Records at the local treasury office will show that TADECO has contributed more than half the total annual income, of which 52% went to the General Fund and 60% to the Special Education Fund (SEF);

WHEREAS, TADECO also has become instrumental in various ways to the development of the towns very close to it particularly this municipality. It helped develop, construct and maintain road networks and drainages and protection dikes by providing heavy equipment and corresponding operator which can be attributed to the mitigation of flood problem in the locality;

WHEREAS, in prior years some parts of this town were once barren, lands were underwater and others uninhabited. With TADECO developing and eventually turning them into productive spots wherein importable bananas are grown, people started to flock and gain entry to the labor force of one of the most respectable figures in the banana industry. It has at present employed thousands of individuals from this town whose families are ascertained of their basic needs. Also included in their social

recovery program is the regular conduct of medical outreach especially in poor communities thru the Antonio O. Floirendo Foundation and in helping this local government unit to materialize its electrification program which benefitted a good number of households even those located in the outskirts of this town;


WHEREAS, TADECO's most admirable deed is their dedicated commitment to give a greater part in the rehabilitation of DAPECOL inmates. At present hundreds if not thousands of inmates serving in the minimum term are given the opportunity to work and are justly compensated, thus enabling them to continue to be economically productive and are assured of a better life with their families the moment they will be out from the four corners of the penitentiary;
