**AMENDING THE AMENDED SB RESOLUTION NO. 2017-11 THAT INSTEAD OF ONE (1) UNIT RESCUE EQUIPMENT (DUMPTRUCK), IT WILL BE ALLOTTED TO THE ACQUISITION OF TWO (2) UNITS RESCUE EQUIPMENT FORWARD TYPE DUMPTRUCKS (SURPLUS) OF THE MUNICIPALITY OF BRAULIO E. DUJALI, DAVAO DEL NORTE.**

WHEREAS, on December 5, 2016, this council had passed Resolution No. 2016-186, otherwise known as a resolution authorizing the Municipal Mayor Atty. Leah Marie Moral-Romano representing the Local Government Unit of Braulio E. Dujali, to enter into Memorandum of Agreement with the Department of Interior and Local Government Regional Office No. XI, represented by its Regional Director, Ananias M. Villacorta, CESO III for the implementation projects such as the Completion of the Municipal Public Terminal and Acquisition of one (1) unit Rescue Equipment (Mini-Dumptruck) of the Municipality of Braulio E. Dujali which budget will come from the Performance Challenge Fund (PCF) in the amount of Three Million Pesos (Php 3,000,000.00) and certifying that said projects are listed in the CY 2016-2020 Local Development Investment Plan (LDIP) of this municipality;

WHEREAS, later the Municipal Mayor requested for the amendment of SB Resolution No. 2016-186, after she received on January 9, 2017 DILG Memorandum Circular No. 2016-167 dated November 23, 2016, stating particularly on 5.1.2.4 that "Proposed projects' must be a whole single project and not a component of other projects", thus the Sanggunian Bayan adopted SB Resolution No. 2017-11, changing the PCF utilization from Completion of





the Municipal Public Terminal and Acquisition of one (1) unit Rescue Equipment (Mini-Dump truck) to purchase of one (1) unit Rescue Equipment (Dump truck);


WHEREAS, the Local Chief Executive forwarded letter dated May 19, 2017 and for the second time requested the honorable council to pass a resolution amending the SB Resolution No. 2017-11 that instead of one (1) unit Rescue Equipment (Dump truck), budget will be allotted to the acquisition of two (2) units Rescue Equipment Forward Type Dump trucks (Surplus) since the amount is not enough in purchasing (1) unit Rescue Equipment (Dump truck);

WHEREFOR, on motion of Hon. Yasmin V. Campion and duly seconded by all members present, it is hereby;

**RESOLVED TO AMEND AS THIS BODY HEREBY AMENDING SB RESOLUTION NO. 2017-11 THAT INSTEAD OF ONE (1) UNIT RESCUE EQUIPMENT (DUMPTRUCK), IT WILL BE ALLOTTED TO THE ACQUISITION OF TWO (2) UNITS RESCUE EQUIPMENT FORWARD TYPE DUMPTRUCKS (SURPLUS) OF THE MUNICIPALITY OF BRAULIO E. DUJALI, DAVAO DEL NORTE.**
