WHEREAS, letter dated August 13, 2020 of Atty. Leah Marie Moral-Romano, Municipal Mayor, indorsing to the Sangguniang Bayan thru Hon. Donna Mae B. Bernadas, Ed.D., the Local Zoning Board of Adjustment and Appeals (LZBAA) Resolution No. 2 series of 2020; "approving and favorably endorsing to the Sangguniang Bayan, this municipality the exception of Lot 3, Block 8, CSD-11-015532, portion of Lot 506 GAS-289 covering an area of 283 sq.m. from land use regulation of residential use to infra/utilities use" was forwarded to this level for deliberation and appropriate action;

WHEREFORE, on motion of Hon. Anna C. Cagulada, duly seconded by all members, it is hereby;


