DECLARING APPROPRIATION ORDINANCE NO. 1 SERIES OF 2017 EMBODYING THE ANNUAL BUDGET CY 2018 OF BARANGAY DUJALI, THIS MUNICIPALITY OPERATIVE EFFECTIVE ON THE DATE OF ITS APPROVAL SUBJECT HOWEVER TO THE FINDINGS AND RECOMMENDATIONS STATED HEREIN.

WHEREAS, the Annual Budget for Calendar Year 2018 of Barangay Dujali, was submitted to this Honorable Council, and later endorsed to the Committee on Finance, Budget and Appropriations for thorough study, after which said committee made the following findings;

- The Annual Budget of the said Barangay has conformed to the Annual Investment Plan for CY 2018 as to the projected amount, income, programs and projects of the said barangay. It was prepared and computed based on the DBM Circular dated June 2017, on August, 2017;
- Local Budget Memorandum (LBM) issued on January 8, 2018, showed that the Internal Revenue Allotment was adjusted for FY 2018, thus affects and reduces the amount of Annual Budget of the said Barangay for CY 2018;
- Thus, the adjustment of Annual Budget exceeded to P8,832.00, and that disbursement of the Maintenance and Other Operating Expenses (MOOE) and or Capital Outlay (CO) in the amount of P 8,832.00 shall be restricted as per LBM latest issuance.

WHEREAS, based on the above findings, this honorable body shall declare the same Appropriation Ordinance No. 1 series 2017 operative, provided however that;

- Restriction of disbursement of MOOE and or CO in the amount of P 8,832.00 shall be observed, as per LBM latest issuance;

WHEREAS, since all other items included in the Annual Budget for Calendar Year 2018 of Barangay Dujali are not contrary to any existing law, rules and regulations, it must be declared operative subject however to the findings and recommendations enumerated above.


WHEREFORE, on motion of Hon. Yasmin V. Campion, duly seconded by all members present, it is hereby


