GRANTING AUTHORITY TO THE LOCAL CHIEF EXECUTIVE, MUNICIPAL ACCOUNTANT AND THE MUNICIPAL TREASURER TO OPEN/CREATE A NEW SPECIAL BANK ACCOUNT INTENDED FOR MUNICIPALITY OF BRAULIO E. DUJALI KC-NCDDP AND TO TRANSFER THE LGU COUNTERPART FROM 20% DEVELOPMENT FUND THIRD CYCLE INCLUDING THE UNEXPENDED BALANCE OF PREVIOUS CYCLES TO THE SAID ACCOUNT.

WHEREAS, letter dated January 16, 2018 of Atty. Leah Marie Moral-Romano, Municipal Mayor, addressed to Hon. Donna Mae B. Bernadas, Ed.D., Municipal Vice Mayor, thru the Sangguniang Bayan, requesting the honorable council to pass a resolution granting authority to the Local Chief Executive, Municipal Accountant and the Municipal Treasurer to transfer the LGU counterpart from the 20% Development Fund to the DSWD Trust Fund, of the Municipality of Braulio E. Dujali, Davao del Norte, was received by this honorable council for immediate and appropriate action;

WHEREAS, an account for DSWD Trust Fund already exists yet it is still required to open/create a new special bank account as mentioned in the Specific Implementation Arrangements (SIA) for KALAHYAN CIDSS-NCDDP Program alone;

WHEREAS, for convenient and easier tracking of project/program expenditures and payables necessary in proper accounting and reporting of fund utilization data;

WHEREAS, the new account shall be named as, Municipality of Braulio E. Dujali KC-NCDDP;


NOW THEREFORE, on motion of Hon. Atty. Yasmin V. Campion, duly seconded by all members present, it is hereby


