WHEREAS, letter dated February 08, 2018 of Atty. Leah Marie Moral-Romano, Municipal
Mayor addressed to Hon. Donna Mae B. Bernadas, Ed. D., Municipal Vice Mayor thru the
Sangguniang Bayan requesting the august body to pass a resolution requesting Engr. Ricardo M.
Oñate, Jr., OIC Executive Director of the Department of Agriculture Field Office XI, Davao City
for the construction of Livestock Auction Market Center in the Municipality of Braulio E. Dujali,
Davao del Norte, was received by this honorable body, and later referred to the appropriate
committee for study and deliberation;

WHEREAS, it is required and is necessary to establish a Livestock Auction Market Center, in
every municipality, that will help generate more revenues for the LGU;

WHEREAS, it also ascertains safety for the livestock and meat products that will be fit for
consumption;

WHEREAS, the desired construction of the Livestock Auction Market Center is situated at **Lot
189-C, Sgs-4297-D** a parcel land (Lot 189-C, Psd-11072644) being a portion of lot 189, Sgs-
4297-D, situated in the Barrio of Poblacion; Municipality of B. E. Dujali Province of Davao del
Norte; Island of Mindanao. Bounded on the N., along line 5-6 by lot 150; along line 6-1 by lot
162, both of Sgs-4297-D on the NE., & S., along line 1-2-3-4 by lot 189-F (Road); on the SW.,

along line 4-5 by lot 189-B, both of the subd. Plan. Beginning at a point marked "1" on plan being N. 54 deg 57' E., 17,558.04 m. from BBM No. 21, Cad-276; thence....

S. 13 deg. 33' E., 52.00 m. to point 2;
S. 38 deg. 14' W., 3.72 m. to point 3;
Due West ., 217.42 m. to point 4;
N. 13 deg. 33' W., 55.00 m. to point 5;
Due East ., 101.63 m. to point 6;
Due East ., 118.79 m. to point of the beginning; and



NOW THEREFORE, on motion of Hon. Nelson C. Baer, duly seconded by all members present, it is hereby;


