WHEREAS, letter dated December 12, 2017 of Atty. Leah Marie Moral-Romano, Municipal Mayor addressed to Hon. Donna Mae B. Bernadas, Ed.D., Municipal Vice Mayor thru the Sangguniang Bayan, requesting the honorable council to pass a resolution giving authority to the Local Chief Executive to grant honorarium to the midwife assigned in this municipality under Rural Health Midwives Placement Program of the Department of Health, was received by this honorable council and later endorsed to the appropriate committee for review and further study;

WHEREAS, letter A of Section 1 of the proposed Contract of Service states that the Local Government Unit shall provide modest board and lodging or monthly honorarium, and that in the event that the local government unit fails to comply, the RHMPP Member shall be pulled out from the area of assignment;

WHEREAS, the Local Government Unit is currently having various healthcare programs, and services of healthcare providers such as midwives are of utmost importance, hence this body prefers to grant to whoever will be assigned in this municipality, the amount of Two


Thousand Pesos (P2,000.00) as monthly honorarium and has to be given priority in this Local Government Unit's Supplemental Budgets;

WHEREFORE, on motion of Hon. Yasmin V. Campion, duly seconded by all members, it is hereby


