WHEREAS, letter dated February 01, 2018 of Atty. Leah Marie M. Romano, Municipal Mayor address to Hon. Donna Mae Baldonado-Bernadas, Ed.D., Municipal Vice Mayor thru the Sangguniang Bayan requesting for legislative measure of appeal to President Rodrigo Roa Duterte, to reconsider funding of the initially proposed projects stipulated in the executive budget and are expected to be implemented upon the DPWH's receipt of GAA of 2018 was received for scrutiny and deliberation;

WHEREAS, attached also is a letter dated November 7, 2017 of Noel C. Basañes, OIC District Engineer, DPWH Region XI informing the Local Chief Executive that their Office will be implementing the projects in this municipality upon the receipt of the GAA 2018 which is expected to be released in January 2018, as follows;

Construction/Improvement of Access Road Junction Road Tuganay-Dujali-Kinamayan to Poblacion New Casay, RJS Purok 5, Poblacion, Cabayangan to Purok Sampaguita leading to Palaγamanan, Barangay Cabaγangan, Braulio E. Dujali, Davao del Norte.

Widening/Deepening and Construction of Earthdike, MAG Creek Tributary of Tuganay River including ROW, Braulio E. Dujali, Davao del Norte, and in addition to the foregoing is the Mayor's proposal for the construction of Braulio E. Dujali-Sto. Tomas Road (Junction Agusan-Davao Road, Tuganay Section-Braulio E. Dujali-Sto. Tomas-Tagum-Panabo Circumferential Road, including ROW, all in Davao del Norte:
