RETURNING BARANGAY RESOLUTION NO. 06 SERIES OF 2018 OF BARANGAY CABAYANGAN, BRAULIO E. DUJALI, DAVAO DEL NORTE, BACK TO ITS BARANGAY OF ORIGIN, FOR INFORMATION

WHEREAS, letter dated March 12, 2018 of Atty. Leah Marie Moral-Romano, forwarding to the Sangguniang Bayan, Barangay Resolution No. 06, series of 2018 of the Sangguniang Barangay of Cabayanan, this municipality for the issuance of Mayor's Permit for cockfighting to be held on March 24, 26 and 28, 2018 was received, considered and later referred to the Committee on Finance, Budget and Appropriations, Ways and Means for study;

WHEREAS, Section 9 (2) states that cockfight shall be held for a period not exceeding three consecutive days in connection with such local fiesta; (3) the proceeds shall go directly to the barangay for Sports Development Program and Peace and Order Program; (5) states that Barangay Resolution is submitted to the Sangguniang Bayan 30 days before the intended playdate, all of the Revised Cockfighting Code of 2017;

WHEREAS, finding that the said resolution did not meet the required timeliness in terms of submission to the Sangguniang Bayan for action, hence;


