REQUESTING HON. EMMANUEL F. PIÑOL, SECRETARY OF THE DEPARTMENT OF AGRICULTURE TO GRANT FREE RICE CROP INSURANCE TO MARGINAL FARMERS OF THE MUNICIPALITY OF BRAULIO E. DUJALI, DAVAO DEL NORTE WHO HAVE BELOW FIVE (5) HECTARES OF FARM AND AN UPDATE REGISTRY SYSTEM BASIC SECTOR IN AGRICULTURE (RSBSA)

WHEREAS, the Municipality of Braulio E. Dujali is an agricultural town having an area for rice production of 2,228.13 hectares and 1,754 farmers. Many of these areas are prone to flood and other natural calamities as well as infestations of pest and disease;

WHEREAS, farmers are our unsung heroes who toil against the elements of nature to feed the nation, who deserve to be given priority and protection. Farmers especially the actual tillers having an area of below five hectares should be protected from damages or losses brought by calamities and infestations;

WHEREAS, when these farmers experience failures of their crop would have difficulty to recover and resort to high interest bearing loans resulting to a more difficult financial situation;

WHEREAS, the Philippine Crop Insurance Corporation (PCIC) is an attached agency of the Department of Agriculture responsible for the protection of our farmers through insurance and is also relying in the Registry System Basic Sector in Agriculture (RSBSA) list in granting the

free insurance to farmers having an area of below three hectares. RSBSA record shows that only 562 rice farmers are registered which is just 32% and 68% are not covered;


WHEREAS, RSBSA list should be updated to accommodate more farmers that are not included and coverage area for insurance should be increased to five hectares;

WHEREFORE, on motion of Hon. Nelson C. Baer, RA, duly seconded by majority of the members, it is hereby;


