WHEREAS, forwarded before this august body is the SP Resolution No. 695; denying Resolution No. 2017-173 of the Sangguniang Bayan of Braulio E. Dujali, this Province, entitled: "Respectfully requesting the Sangguniang Panlalawigan of the Province of Davao del Norte to reconsider its findings in Municipal Ordinance No. 2017-197, and later referred to the Committee on Health for further study;

WHEREAS, this body found in RA 7160 known as the Local Government Code of 1991, Section 2 (a) states that "it is hereby declared the policy of the State that the territorial and political subdivisions of the State shall enjoy genuine and meaningful local autonomy to enable them to attain their fullest development as self-reliant communities and make them more effective partners in the attainment of national goals", thus this body believes it proper to reconsider the same;




