RECOMMENDING TO ATTY. LEAH MARIE MORAL-ROMANO, MUNICIAL MAYOR TO ISSUE MAYOR'S PERMIT FOR THE CONDUCT OF COCKFIGHTING ON MAY 15, 2018 IN CONNECTION WITH THE CELEBRATION OF PATRONAL FIESTA OF BARANGAY CABAYANGAN, BRAULIO E. **DUJALI, DAVAO DEL NORTE**

WHEREAS, Resolution No. 10 series of 2018 of the Sangguniang Barangay of Cabayangan, this municipality, was forwarded to the Sangguniang Bayan, and later referred to the Committee on Ways and Means for appropriate action,

WHEREAS, after thorough discussion on the said request, the committee has made the following findings, and adopted by this body;

- Schedule of cockfighting is on May 13, 14 and 15, 2018,
- COMELEC Resolution No. 10246 promulgated January 15, 2018; calendar of activities and periods of certain prohibited acts in connection with the May 14, 2018 synchronized Barangay and Sangguniang Kabataan (SK) elections, must be observed,
- From April 14, 2018 to May 14, 2018 Holding of dances, lotteries, cockfights, games or other performances for the purpose of raising funds is prohibited as per Sec. 97 of Omnibus Election Code.

WHEREAS, despite the findings stated above, this honorable body recommended for the issuance of Mayor's Permit for the conduct of one (1) day cockfighting only on May 15, 2018 provided that all provisions of the Revised Cockfighting Code 2017 of this municipality shall strictly be observed;
