- That COMELEC Resolution No. 10246 promulgated January 15, 2018, stated that from April 14, 2018 to May 14, 2018 holding of dances, lotteries, cockfights, games or other performances for the purpose of raising funds are prohibited as per Sec. 97 of Omnibus Election Code,
