WHEREAS, Resolution No. 07 series of 2018 of Barangay Tanglaw, this municipality was brought to the attention of this august body for appropriate action;

WHEREAS, after thorough discussion on the said request, this body has made the following findings and adopted the same, to wit;

- That schedule of cockfighting is on April 30, 2018 to May 1, 2 and 3, 2018 in line with the Patronal Fiesta of GKK Sta Cruz, in the said barangay, and that the name of Patron Saint was not mentioned,
- That COMELEC Resolution No. 10246 promulgated January 15, 2018, stated that from April 14, 2018 to May 14, 2018 holding of dances, lotteries, cockfights, games or other performances for the purpose of raising funds are prohibited as per Sec. 97 of Omnibus Election Code,


WHEREAS, based on the foregoing, this honorable body moved to approve and return the same;

WHEREFORE, on motion of Hon. Melfar C. Aguiluz duly seconded by all members present, it is hereby;


