RETURNING BARANGAY RESOLUTION NO. 013 SERIES OF 2018 OF BARANGAY CABAYANGAN, BRAULIO E. DUJALI, DAVAO DEL NORTE BACK TO ITS BARANGAY OF ORIGIN, FOR INFORMATION AND GUIDANCE

WHEREAS, letter dated April 27, 2018 of Atty. Leah Marie Moral-Romano, Municipal Mayor, addressed to Vice Mayor Donna Mae B. Bernadas, thru the Sangguniang Bayan, forwarding Barangay Resolution No. 013 series of 2018 of the Sangguniang Barangay of Cabayangan, for issuance of Mayor's Permit for the cockfighting on May 23-25, 2018 in connection with the celebration of Araw ng Cabayangan was considered and later referred to the Committee on Finance, Budget and Appropriations, Ways and Means for study;

WHEREAS, Presidential Decree 449 and Section 8, sub-paragraph H of Municipal Ordinance No. 2017-196, states that holding of cockfights, except as provided in this ordinance, cockfighting shall be allowed only in cockpits, during Sundays and legal holidays and during local fiestas for not more than three days. And nothing is mentioned about permission given to celebration of Foundation, Anniversaries or Araws;

WHEREAS, the committee made its findings and recommendation to which this body has adopted that the said barangay will conduct cockfighting in connection with the celebration of its foundation anniversary which is inconsistent to existing laws and Municipal Ordinance No. 2017-196, of this municipality, thus return of the same resolution is necessary;
