WHEREAS, Engr. Jay R. Colaljo, Municipal Engineer, has sent a letter dated April 10, 2018, and the same was duly noted by Atty. Leah Marie Moral-Romano, the honorable mayor, informing this honorable body of the present condition of a Hanging Bridge with steel gate situated somewhere in Bacali-Casig-ang and Tanglaw area;

WHEREAS, according to the gentleman, the structure is already dilapidated and the worst is that, it causes flooding in the area, especially now that is already rainy season;

WHEREAS, this honorable body after a careful discussion is amenable to the idea of Engr. Colaljo and supported by a representative of Tanglaw Plantation Operation, the company that built the bridge sometime ago, that it is better to remove the bridge and steel gate to clear the area, and in due time replace it with another, than have it fixed;

WHEREAS, there is indeed a need to secure permission from Tanglaw Plantation Operation, the one that installed the structure, before demolition can be carried out;


WHEREFORE, on motion of Hon. Ricky T. Delco, duly seconded by the majority of the members, it is hereby;


RESOLVED FURTHER, that copies of this resolution be furnished to the Office of the Barangay Tanglaw, this municipality for information and guidance.
