REQUESTING SECRETARY EMMANUEL F. PIÑOL OF THE DEPARTMENT OF AGRICULTURE TO INCREASE BUYING SUPPORT PRICE OF PALAY OF THE NATIONAL FOOD AUTHORITY (NFA) FROM P17.00 PER KILO TO P22.00 PER KILO AND PROVISION OF ADDITIONAL FUND TO NFA FOR THE IMPLEMENTATION OF THEIR RICE PROCUREMENT PROGRAM

WHEREAS, the National Food Authority (NFA) was created by the virtue of Presidential Decree No. 4 and is mandated to ensure national food security and stabilize supply and prices of staple cereals both in the farm and consumer levels with the mission of ensuring reasonable rate of return to Filipino farmers, provide adequate supply and affordable rice and corn for the country, and promote the integrated growth and modernization of rice and corn marketing industry to enable it to compete in the global market;

WHEREAS, the National Food Authority's vision is to achieve a national sustainable mechanism for ensuring stabilization of prices and supply of rice and corn while increasing the income of Filipino farmers, with that provision of additional fund for the implementation of various programs is indeed necessary;

WHEREAS, the agency performs various activities and strategies to attain the said mandates and one of this is the buffer stocking activity wherein the NFA buys palay from the farmers

and/or farmer's organizations at the government support price of Php17.00/kg that takes effect February 1, 2009;

WHEREAS, it is high time that the government support price will be increased from Php17.00/kg to Php22.00/kg so that the farmers will be encouraged to sell their palay to the NFA;


WHEREFORE, on motion of Hon. Nelson C. Baer, RA, duly seconded by all members, it is hereby;


