Their tasks include implementation of programs beneficial to all indigenous people; formulate policies that ascertain upliftment of their socio and economic well-being and acts as arbiters in case of disputes among them;

WHEREAS, most of the activities that these leaders do are officiating tribal wedding ceremonies; dedication; Pag-indo program; settling disputes; issuance of tribal certification and holding of programs and activities that are helpful in preserving their culture and tradition;

WHEREAS, in catering the needs of the constituents of the tribal community, a tribal hall is very beneficial to serve as the place for Indigenous Cultural Communities and for the Indigenous People to transact business such as securing documents or any other needs;

WHEREAS, huge amount of fund is needed for the establishment of the tribal hall, sad to say the Indigenous People (IPs) has no capacity in the meantime to raise such;
