**GIVING AUTHORITY TO ATTY. LEAH MARIE MORAL-ROMANO, MUNICIPAL MAYOR TO ENTER INTO MEMORANDUM OF AGREEMENT BY AND BETWEEN THE LOCAL GOVERNMENT UNIT OF BRAULIO E. DUJALI AND THE DAVAO REGIONAL MEDICAL CENTER REPRESENTED BY BRYAN O. DALID, MD, FPCS, FPALES, MEDICAL CENTER CHIEF II, IN CONNECTION WITH THE IMPLEMENTATION OF AID FOR INDIVIDUAL IN CRISIS SITUATION (AICS) AMOUNTING TO FIFTY THOUSAND PESOS (PHP50,000.00)**

WHEREAS, the Municipality of Braulio E. Dujali is a 4<sup>th</sup> class municipality consisting of five (5) barangays namely: Barangay Tanglaw with 13,737 residents, Barangay Dujali with 7,438 residents, Barangay New Casay with 1,842 residents, Barangay Cabayanan with 4,893 residents and Barangay Magupising with 2,194 residents of which most of the populace of this municipality are farmers and laborers with an average or minimal income, who, at the time when a family member gets sick, medication becomes costly for them that is why some will seek the services of "albularyos" or most often, self-medicate, both of which are putting their patient's health at risk;

WHEREAS, the Davao Regional Medical Center is a government facility that provides low-priced medical services to patients from entire region particularly those that came from Province of Davao del Norte wherein this municipality belongs;



WHEREAS, this Memorandum of Agreement is initiated to help indigent patients whether in-patient or out-patient from the Municipality of Braulio E. Dujali who seeks medical assistance from Davao Regional Medical Center of which medical coverage includes medicines, laboratory test, thyroid scan, T3, T4, TSHR, dialysis, ECG, X-ray, Cobalt, CT Scan, Ultrasound Examination lower and upper abdomen, MRI and other medical and laboratory procedures excluding provision of blood;

WHEREAS, contents of the said MOA are as follows:

#### MEMORANDUM OF AGREEMENT

This Agreement made and entered into by between:

MUNICIPALITY OF BRAULIO E. DUJALI, Province of Davao del Norte, a local government unit existing and created under the laws of the Republic of the Philippines, represented in this act by HON. ATTY. LEAH MARIE MORAL-ROMANO, Municipal Mayor, pursuant to an authority from Sangguniang Bayan Resolution No. 2018-090, hereinafter referred to as the BRAULIO E. DUJALI;

DAVAO REGIONAL MEDICAL CENTER, with principal office address at Apokon, Tagum City, represented herein by its Medical Center Chief II, BRYAN O. DALID, MD, FPCS, FPALES, hereinafter referred to as the DRMC;

#### WITNESSETH:


WHEREAS, the implementation of the AID for Individual in Crisis Situation (AICS), a Municipal Social Welfare and Development Office (MSWDO) Assistance Program is undertaken by and through the representation of Braulio E. Dujali. Under this program, the amount of Fifty Thousand Pesos (Php50,000.00) as initial fund is appropriated as aid to indigent patient of BRAULIO E. DUJALI confined at the DRMC;

WHEREAS, numerous indigent patients from Braulio E. Dujali are in need for medical assistance; and

WHEREAS, the DRMC has the facilities to provide the service and/or medical interventions needed by said patients requesting for medical assistance and is willing to cooperate/coordinate and monitor the implementation through its Aid for Individual in Crisis Situation Program.

NOW THEREFORE, for and in consideration of the foregoing premises, the PARTIES hereto hereby agree on the following:

1. The Municipality of BRAULIO E. DUJALI through the MSWDO shall identify and recommend to the Office of the Municipal Mayor indigent patients entitled to avail the Program;
2. All letter- referral shall bear the signature of the Municipal Mayor or the Municipal Administrator, his duly authorized representative;
3. The following procedures in the acceptance and coverage of beneficiary-patient of herein program shall be as follows,;





- a. The beneficiary-patient shall secure from the LGU the required letter- referral;
  - b. The beneficiary-patient enrolled under herein may coordinate with the 1081 social worker to determine the area where the letter- referral shall received. The policy of "No Letter- Referral, No Coverage" shall be observed and followed all the time;
4. The coverage applies to in-patient and out-patient services. All referral for Pay Ward Services shall be indicated in the letter- referral, otherwise the patient shall automatically be admitted at the a Service Ward;
  5. Medical coverage referred to in this Agreement shall include medicines, laboratory test, thyroid scan , T3, T4, TSHR dialysis, ECG, X-ray, Cobalt, CT-Scan, Ultrasound Examination lower and upper abdomen, MRI and other medical and laboratory procedures. Provision for blood however, is excluded;
  6. The amount of Fifty Thousand Pesos (Php50,000.00) representing the initial amount of herein assistance program shall be deposited under the account of the DRMC immediately before the patient is referred to and admitted under this program;
  7. The DRMC though its Accounting Office, shall furnish Braulio E. Dujali on a quarterly basis, or upon letter request by the LGU a list of patient who have availed the assistance for recording purposes of the Municipality of BRAULIO E. DUJALI;
  8. All payments and releases under this program shall be made in accordance with existing government accounting and auditing rules and regulations;
  9. The life of this agreement shall subsist and remain effective until terminated by both parties;
  10. The Agreement shall be deemed effective upon receipt by the DRMC of check issued by the Braulio E. Dujali covering the release of funds for the said assistance.




