WHEREAS, the Supplemental Annual Investment Plan (SAIP) No. 1 CY 2018 of Barangay Tanglaw, this municipality was submitted to the Sangguniang Bayan and the later was referred to the Committee on Finance, Budget and Appropriations for study;

WHEREAS, the committee thoroughly reviewed the said SAIP, and per Committee Report No. 35 dated July 4, 2018, this body moved to return the same with following findings and recommendations, to wit;

Findings:

- Supplemental Annual Investment Plan was submitted late.
- Source of the Supplemental in the amount of P70,000.00 was declared savings by the Barangay Development Council (BDC), however only P30,000.00 was approved by the Sangguniang Barangay.
- Resolution number reflected in the SAIP form did not conform to the number of the approved resolution of the Sangguniang Barangay;

Recommendations:


- The BDC shall approve a resolution declaring the amount for savings and re-appropriating the same to the proposed projects/programs.
- The BDC shall approve and endorse the SAIP to the Barangay Council.
- The Barangay Council shall approve and endorse to the Sangguniang Bayan the declaration of savings and the re-appropriation of the same.
- The Barangay Council shall adopt and endorse the SAIP to the Sangguniang Bayan for review and approval;

On motion of Hon. Melfar C. Aguiluz duly seconded by the majority of the members, it is hereby;


