REQUESTING THE NATIONAL HISTORICAL COMMISSION OF THE PHILIPPINES TO PROVIDE COPY OF CERTIFICATION CERTIFYING THE ACTUAL FOUNDING ANNIVERSARY OF THE MUNICIPALITY OF BRAULIO E. DUJALI IN THE PROVINCE OF DAVAO DEL NORTE

WHEREAS, previously, the Sangguniang Bayan of Braulio E. Dujali passed Resolution No. 2018-019, otherwise known as "Requesting His Excellency Rodrigo Roa Duterte, President of the Republic of the Philippines to declare every 8th day of March as special non-working holiday in the Municipality of Braulio E. Dujali in celebration of the foundation day", which was later endorsed by the Office of the President to the National Historical Commission of the Philippines for comments;

WHEREAS, Dr. Rene R. Escalante, Chairman, National Historical Commission of the Philippines, furnished to the Secretary to the Sanggunian, this municipality, copy of his endorsement letter dated April 2, 2018 addressed to Atty. Ryan Alvin R. Acosta, Deputy Executive Secretary for Legal Affairs, Office of the President of the Philippines stating therein the Founding Anniversary of the Municipality of Braulio E. Dujali is on March 7 based on their record;

WHEREAS, the Second Sangguniang Bayan of this municipality passed and approved Municipal Ordinance No. 11 s. 99, otherwise known as "An ordinance declaring March 8 as Araw ng Braulio E. Dujali pursuant to R.A. 8473";




