**REQUESTING DR. ANNABELE P. YUMANG, MD, MCH, DIRECTOR IV, DEPARTMENT OF HEALTH, REGION XI, FOR THE ASSIGNMENT OF ADDITIONAL PHYSICIAN TO BE ASSIGNED IN THE MUNICIPALITY OF BRAULIO E. DUJALI UNDER THE AUGMENTATION PROGRAM OF THE DEPARTMENT OF HEALTH (DOH)**

**WHEREAS**, the Municipality of Braulio E. Dujali is a fourth class municipality and has a total population of 30,104. No private hospital or medical clinics are available in the area, thus, the Municipal Health Officer, being the only medical practitioner is the one who solely caters to all children, elderly, men and women needing medical attention;

**WHEREAS**, it has already been a common sight in the Municipal Health Office of many ailing people queuing for check-up. In some cases people would end up self-medicating rather than wait for longer hours, something that is likely to put patient's health at risk;


**WHEREAS**, the Municipal Health Officer also has other functions to attend to aside from conducting medical check-ups. These are instances that she would be out on training and seminar, thus an alternate doctor is necessary;


