**EXPRESSING COMMITMENT TO PROVIDE FUNDS FOR THE COVERING OF OPEN-LINED CANAL WITH CONCRETE PAVEMENT IN THE BEDHOMES AND LAMSHED RESETTLEMENT PROJECTS WITHIN THREE (3) YEARS**

WHEREAS, this LGU has applied Certificate of Registration (COR) and License to Sell (LS) with the Housing and Land Use Regulatory Board (HLURB) for BEDHOMES and LAMSHED resettlement projects, which unfortunately did not pass the board's validation. One reason is that the drainage canal is of sub-standard quality and is uncovered;

WHEREAS, this honorable body thru a resolution has asked the HLURB to reconsider its findings and to finally approve the application and subsequently release the Certificate of Registration and the License to Sell;

WHEREAS, in response to said appeal, the HLURB gave a recommendation that the LGU has first to comply with the required standards as per HLURB Resolution No. R-97, series of 1982 (Annex 2) requiring that canals must be covered with load bearing pavement to which this body is amenable. Thereby committing that funds shall be provided for this purpose and compliance shall be within three (3) years;

WHEREFORE, on motion of Hon. Ricky T. Delco, duly seconded by the majority of the members, it is hereby;

**RESOLVED TO EXPRESS AS THIS BODY HEREBY EXPRESSES COMMITMENT TO PROVIDE FUNDS FOR THE COVERING OF OPEN-LINED CANAL WITH CONCRETE PAVEMENT IN THE BEDHOMES AND LAMSHED RESETTLEMENT PROJECTS WITHIN THREE (3) YEARS**


RESOLVED FURTHER, that copies of this resolution be furnished to the Office of Housing and Land Use Regulatory Board (HLURB) XI for information and guidance.
