**A RESOLUTION REQUESTING THE PHILIPPINE NATIONAL POLICE DIRECTORATE FOR LOGISTICS UNDER THE INFRASTRUCTURE AND FACILITIES MANAGEMENT DIVISION FOR THE CONSTRUCTION OF STANDARD TYPE B/C POLICE STATION BUILDING FOR BRAULIO E. DUJALI POLICE STATION**

WHEREAS, the constitution provides that it is the policy of the state to maintain peace and order, protection of life, liberty and property and promotion of the general welfare;

WHEREAS, the Philippine National Police has been the country's primary law enforcement agency that serves the Filipino public by maintaining public safety;

WHEREAS, while the PNP is at the forefront of ensuring peace and order and public security, there exist challenges that restrain the organization's delivery of police services such as but not limited to insufficient funding support, lack of equipment and tedious procurement process;

WHEREAS, Senate Bill No. 1544 introduced by Senator Panfilo F. Lacson "An Act Providing for the Modernization of the Philippine National Police, appropriating funds therefor and for other purposes" shall be known as the PNP Modernization Act of 2017;

WHEREAS, it is declared by the policy of the state to implement a modernization program for the Philippine National Police with the end view of transforming it into a highly efficient, capable, and competent national police force;

WHEREAS, the PNP modernization program consists of the infrastructure development and facilities, upgrading camps, buildings, police stations and police community and precincts and support facilities and administrative services;

WHEREAS, the Braulio E. Dujali Police station was inaugurated on the 14<sup>th</sup> day of September 2009 with the support of the Hon. Congressman Antonio D. Lagdameo Jr. (2<sup>nd</sup> District, Davao del Norte) and the Hon. Mayor Lolita A. Moral;

WHEREAS, the structure was designed in a "Bungalow" type of building and not the standard type b/c police station which at present is among the police stations in the Province of Davao del Norte considered to be a very vulnerable target by the Lawless Armed Groups considering its type of building and its perimeter defenses are not so well-structured;



WHEREFORE, on motion of Hon. Ricky T. Delco and duly seconded by all members present, it is hereby;




