DECLARING SAVINGS PORTION OF THE AMOUNT ALLOTTED TO COUNTERPART TO BE USED AS OUTSIDE FUNDED PROJECTS UNDER THE 2018 20% DEVELOPMENT FUND AMOUNTING TO ONE HUNDRED FIFTY THOUSAND PESOS (P150,000.00) AND RE-APPROPRIATING THE SAME FOR THE COMPLETION OF BARANGAY HEALTH STATION OF BARANGAY DUJALI, THIS MUNICIPALITY


