**CONFIRMING THE CANCELLATION OF MUNICIPAL DEVELOPMENT COUNCIL (MDC) RESOLUTION NOS. 18 AND 19, ALL SERIES OF 2018 OF THE MUNICIPALITY OF BRAULIO E. DUJALI, DAVAO DEL NORTE**

WHEREAS, MDC Resolution No. 23 series of 2018 containing a request for cancellation of MDC Resolution Nos. 18 and 19 all series of 2018, was received by this honorable council for consideration;

WHEREAS, MDC Resolution No. 18 contains a request for an amendment of identified project to be funded under the 2016 Performance Challenge Fund (PCF) from *Procurement of Two (2) units Rescue Equipment Forward Type Dumptruck (Surplus) to Procurement of One (1) Unit Brand New Dumptruck* amounting to Three Million Pesos (P3,000,000.00) while MDC Resolution No. 19 contains a request to grant authority to the Local Chief Executive to purchase the said vehicle;

WHEREAS, this honorable body found out that said procurement of vehicle being contained in the foregoing resolutions was not included in the Annual Investment Plan (AIP) of the LGU and also it was not clearly mentioned that the unit will be used for disaster rescue purposes, as per project menu of the funding agency;

WHEREAS, after thorough discussion and deliberation, the members of this body is of the consensus to approve the same;

NOW THEREFORE, on motion of Hon. Nelson C. Baer, duly seconded by the majority of the members present, it is hereby;




