WHEREAS, one of the requirements in the procurement of vehicle is a resolution from this honorable body that grants authority to the Local Chief Executive to purchase said vehicle;


WHEREAS, after thorough discussion and deliberation, this honorable body moved to approve the same;

NOW THEREFORE, on motion of Hon. Ricky T. Delco, duly seconded by the majority of the members present, it is hereby;


