- The said amount was declared savings portion of the Personal Services of Barangay New Casay.


WHEREAS, this body on unanimous accord moved to declare the same;

WHEREFORE, on motion of Hon. Melfar C. Aguiluz, and duly seconded unanimously, it is hereby;


