WHEREAS, issuance of mayor's permit is recommended provided that all provisions of Revised Cockfighting Code 2017 of this municipality shall be strictly observed;


WHEREFORE, on motion of Hon. Hon. Ricky T. Delco, duly seconded by majority of the members present, it is hereby;
