WHEREAS, the DONOR is the owner of the parcel of land, LOT 3827 situated in the Balisong, Barrio of Cabayangan, Municipality of Carmen (now part of the Municipality of Braulio E. Dujali), Davao del Norte, by virtue of the Deed of Absolute Sale dated January 25, 1989, notarized by Atty. Crisanto D. WHEREAS, the DONOR do hereby state, for the purpose of giving full effect to this donation that they have reserved for themselves in full ownership sufficient property to support them in a manner appropriate to their needs;

WHEREAS, in consideration of public service, the DONOR, by these presents, VOLUNTARY gives, transfers and conveys by way of DONATION, unto the said DONEE, portion of the above-described real property (for subdivision survey), containing an area of ONE HUNDRED (100) square meters; subject to the following terms and conditions;

- 1. The donated area shall be located in the center of the land along the access road.
- 2. The subdivision survey and transfer of the title of the subject donated lot shall be shouldered by the DONEE;
- 3. That the donated lot shall be used for the water system project of the municipality of Braulio E. Dujali;

WHEREAS, the DONEE hereby accepts this donation and expresses their gratitude for the act and generosity of the donor.

NOW THEREFORE, for and in consideration of the above-agreement, the parties herein shall have the ORIGINAL CERTIFICATE OF TITLE No. P-794 CANCELLED by the Register of Deeds for the Province of Davao and in lieu thereof to issue new Transfer Certificates of Title in favor of the respective owners.
