RECOMMENDING TO ATTY. LEAH MARIE MORAL-ROMANO, MUNICIPAL MAYOR FOR THE ISSUANCE OF MAYOR'S PERMIT FOR SPECIAL COCKFIGHTING TO BARANGAY NEW CASAY, BRAULIO E. DUJALI, DAVAO DEL NORTE ON DECEMBER 19, 20 AND 21, 2018 IN CONNECTION WITH THE CELEBRATION OF PATRONAL FIESTA OF THE SAID BARANGAY

WHEREAS, Resolution No. 038 series of 2018 of Barangay New Casay, this municipality was brought to the attention of this august body for appropriate action;

WHEREAS, the said resolution states among others the request for a Mayor's Permit for special cockfighting to be held on December 4, 5 and 6 2018 in celebration of 27th Founding Anniversary and on December 19, 20 and 21, 2018 in celebration of Patronal Fiesta at the said barangay;

WHEREAS, **SECTION 8 of Revised Cockfighting Code of 2017 of this municipality, provides that, (H) Holding of Cockfights. "Except as provided in this ordinance, cockfighting shall be allowed only in cockpits, during Sundays and legal holidays and during local fiestas for not more than three days."** and **SECTION 9 of the same code provides that, (1) it shall be held on the occasion of the local fiesta celebration only....."**

WHEREAS, per Committee Report No. 72 dated November 28, 2018, Mayor's Permit shall be issued only for the conduct of Special Cockfighting on December 19, 20 and 21, 2018 and that all provisions of Revised Cockfighting Code 2017 of this municipality shall be strictly observed;

WHEREFORE, on motion of Hon. Nelson C. Baer, duly seconded by Hon. Ricky T. Delco, Hon. Dexter G. Mendio, Hon. Eduardo, Hon. Melfar C. Aguiluz, Hon. Yasmin V. Campion, it is hereby;

RESOLVED TO RECOMMEND AS THIS BODY HEREBY RECOMMENDS, TO ATTY. LEAH MARIE MORAL ROMANO, MUNICIPAL MAYOR FOR THE ISSUANCE OF MAYOR'S PERMIT TO BARANGAY NEW CASAY, BRAULIO E. DUJALI, DAVAO DEL NORTE ON DECEMBER 19, 20 AND 21, 2018 IN CONNECTION WITH THE CELEBRATION OF PATRONAL FIESTA OF THE SAID BARANGAY
