WHEREAS, sources of these funds came from the unused and excess budget allocation of various projects implemented in the current and previous years and personnel services from unfilled positions of different offices;



WHEREFORE, upon motion of Hon. Yasmin V. Campion duly seconded by the majority of the members present, it is hereby;




