APPROVING THE DISCONTINUANCE OF THE PROJECT FUNDED UNDER THE 2018 20% DEVELOPMENT FUND NAMED "MAINTENANCE OF ROADS AND DRAINAGE CANAL" AND DECLARING SAVINGS ITS REMAINING BUDGET ALLOCATION AMOUNTING TO P680,824.98 AND RE-APPROPRIATING THE SAME TO THE PROJECT NAMED, "REHABILITATION/IMPROVEMENT OF ROADS AND DRAINAGE CANAL" OF THE MUNICIPALITY OF BRAULIO E. DUJALI, DAVAO DEL NORTE

WHEREAS, MDC Resolution No. 32 series of 2018 was endorsed to this honorable council for thorough review and approval;

WHEREAS, Section 2.3 of the Department of Interior and Local Government (DILG) and Department of Budget and Management (DBM) Joint Memorandum Circular (JMC) No. 2017-1 dated February 22, 2017 states that, "All development projects to be funded under the 20% Development Fund (DF) shall contribute to the attainment of desirable socio-economic development and environmental management outcomes of the LGU, and shall partake the nature of investment or capital expenditures", thus there is

a need to discontinue the said project since Repair and Maintenance on Development Projects are under the MOOE, thus can no longer be charged against the 20% DF, except those projects that are classified as Capital Outlay;

WHEREAS, the amount of P680,824.98 initially allocated shall be declared savings and subsequently be made available to fund;

WHEREAS, after the discontinuing the said projects, its remaining budget allocation shall be declared savings and re-appropriated to another project named, "Rehabilitation/Improvement of Roads and Drainage Canal" as presented hereunder;

WHEREFORE, upon motion of Hon. Yasmin V. Campion duly seconded by the majority of the members present, it is hereby;




