DECLARING APPROPRIATION ORDINANCE NO. 01 SERIES OF 2018 EMBODYING THE ANNUAL BUDGET FOR CY 2019 OF BARANGAY CABAYANGAN, BRAULIO E. DUJALI, DAVAO DEL NORTE, OPERATIVE, EFFECTIVE ON THE DATE OF ITS APPROVAL SUBJECT HOWEVER TO THE FINDING AND RECOMMENDATION STATED HEREIN.

WHEREAS, Appropriation Ordinance No. 01 embodying the Annual Budget for Calendar Year 2019 of Barangay Cabayangan, Braulio E. Dujali, Davao del Norte in the amount of Five Million Ninety Two Thousand Five Hundred Forty Six Pesos (P5,092,546.00) was submitted to this Honorable Council, and was later referred to the Committee on Finance, Budget and Appropriations for further study;

WHEREAS, this body is amenable to the Committee's recommendation to integrate the Rehabilitation and Anti-Drug Abuse Campaign with an allocation in the amount of P20,000.00 in the succeeding Supplemental AIP, since this could not be found in their AIP for 2019, and that the same amount shall not be disbursed thus be considered as Unappropriated Balance. Further, the said amount shall be made available in the next Supplemental Budget;

WHEREFORE, on motion of Hon. Yasmin V. Campion, and seconded unanimously, it is hereby;


